Roles and responsibilities of the Mandal Educational Officer and Mandal level committee is as follows.

- Receiving of question papers from district and distribute to all schools
- Ensuring a good leak proof storage point
- Identification of Spot valuation Centre with good accommodation
- Identification and serving orders to the evaluators in the Mandal
- Act as a Camp Officer for smooth conduct of Examinations, Paper corrections and uploading of the data on the website.
- Observe the process of posting of marks as per the academic standards by the evaluator in the prescribed format
- De-coding of answer scripts should be done
- Transportation of the question papers to the allotted spot valuation centres i.e Mandal
- Constitute Mandal verification Team in order to verify 10% answer scrips of other allotted mandal.

Further All the Mandal Educational Officers are instructed **to identify Spot valuation Centre** with good accommodation for Summative Assessments. They are further requested to send the names of committee members as well as particulars of spot valuation center in a given proforma (enclosed) to the undersigned for onward submission of the same to the higher authorities.

Procedure of jumbling of answer scripts valuation as follows:

- List out number of High school/institutions having classes VI-X in the mandal
- The Headmaster of High School/Institution should bundle the answer scripts at the end of examination of classes VI-X
- The subject wise/class wise sealed bundles should be sent to the allotted paper correction centre i.e Mandal Headquarter
- The bundles will be unsealed in the presence of MEO and other committee members at the time of allotment of answer scripts for evaluation
- Identification and serving orders to the evaluators in the mandal
- The Evaluator should enter the marks academic standard wise marks secured by the student in the given format which was printed on part B of question paper
- The M.E.O and other committee members should take care on uploading of students' performance in the online format.
- MEO should keep in contact with the state level technical support group

Further All the Deputy Educational Officers are instructed to oversee the spot valuation procedure such as identification of spot valuation centre, identification and serving orders to the evaluators , valuation process and uploading of data of their respective mandals. They shall visit the valuation camps frequently for the smooth conduct of procedure.

Further all the personnel are requested to go through the concerned GOs which are enclosed with these proceedings and act accordingly
