The attention of all the Regional Joint Directors of School Education and the District Educational Officers in the State is informed that, some of the District Educational Officers have requested certain clarifications in the reference 8th to 10th read above. In this connection, the following clarifications are issued and they are requested to take further necessary action in the matter promptly.

9	In the ITEM NO. VII & VIII under TABLE – 2 (B) in G.O.Ms.No.29 School Education (SER.II) Department dated:22-05-2017, the UP Schools consisting of VI & VII, VI to VIII and having enrolment > 60 & 80 respectively can straight away upgraded I to full pledged High School from 2017-18 onwards by opening VIII & IX Classes, subject to availability of required infrastructure facilities in the school. Necessary proposals shall be submitted. Therefore, it is requested for clarification whether the posts can be allotted as per the TABLE-3 (A) under Rationalization or shall await permission orders to upgrade the School from the GOVT and report on availability of Infrastructure facilities. This doubt was aroused because as per the instructions of the GOVT. and G.O. Ms. No. 524. The permission from the Competent Authority is required for up-gradation of schools.	Staff may be provided to such schools as per the staffing pattern as per (vi) Table – II-B in G.O.Ms.No.29 SE (Ser.II) Department, Dated: 22.05.2017. Upgraded schools may start functioning, pending submission of necessary proposals for up gradation of such schools and obtaining formal approvals from the competent authority. Necessary proposals should be submitted expeditiously/on priority.
10	In the year 2009, UP School was upgraded as High School. Please clarify whether the school seniority of such teachers working in the said upgraded schools can be counted from its up-gradation or service rendered before the up-gradation also.	School seniority shall be taken
11	During the year 2015 some schools were merged in other Schools or Model Primary Schools. In such cases it is requested for clarification, how to reckon their station seniority either from date of merging or the service rendered before merging of the school. 1	Certain Head Masters have been transferred as Mandal Educational Officers and consequently vacancies of H.Ms Gr.II have arisen. These posts have been filled in on adhoc basis on promotions as Head Masters Gr.II. Whether these adhoc promotions as Head Master Gr.II may be shown as vacant or not in transfers 2017.	Follow Rule 13 (g) of G.O.Ms.No.32 SE (Ser.II) Dept., Dated: 04.06.2017 and clarification Point No. 2 issued C.S.E. Proc.Rc.No. 190/Estt-III/2017, Dated:08.06.2017.

Further, all the Regional Joint Directors of School Education and the District Educational Officers in the State are informed to note the following clarifications and advise the teachers, Headmaster Grade II accordingly.

1. Allow performance points in respect of HMsGr.II / Teachers also working on deputation in I.A.S.Es / C.T.Es / D.I.E.Ts/under work adjustments on certification issued by the Head of the institutions concerned. This may be allowed at the time of verification of certificates.
2. Do not shift the Language Pandits in the Government / Z.P. High Schools for the reason, that the posts of LPs are not mentioned in the TABLE- III A in G.O.Ms. No. 29 Edn. Dt: 22.05.2017 except in the event that the posts are upgraded and needed to UP Schools as deficit.
3. Under Rule 7 Special Points sub rule iii "the benefit of spouse points shall be applicable to one of the spouse once in 5 / 8 years only". It may be considered 5 years / 8 academic years instead of 5/8 years.
4. Under Rule 10 (d) participation of school children in inspire/ science fair / exhibition organized by State / Central Government the performance points may be allowed in 5 years / 8 academic years provided that they have not availed during the said period.
5. When a post is identified for shifting under Rationalization in a particular school where there is a teacher due to be retired on 30th, June, 2017 in such school, the post in which the retiring person is working may be shifted instead of other working teachers in the school.
6. Spouse of the service person working in C.I.S.F. may also be considered under Rule 12 (k) of preferential category in the G.O.Ms.No.32 SE (Ser.II) Department, Dated: 04.06.2017.
7. Teachers working in the Districts and covered under G.O.610 may also apply for transfers as per their eligibility.
