- 3. CSE, SCERT team, Director RMSA, RJDSE, DEO visit the training centers and review with the trainees on the quality & effectiveness of training programme.
- 4. Earned leave will be preserved as per the ruling 15 under FR 82.
- 5. They has to look after all the arrangements like logistics, attendance, feedback, material etc of all batches at that venue.

Attendance:

- 1. They are requested to instruct all the teachers to carry their e.Hazar Devices (FP & Iris) given at school level to respective training centers for attendance.
- 2. The workshop will be organized to check the devices in case of any issues received for implementation of e.H.za.
- 3. Proper facilities should be ensured at the training venues. Biometric attendance of trainees & Resource persons twice a day should be ensured.
- 4. In case of failure of attendance, such issues to be addressed to the device vendor, in turn, the device vendor will resolve the problem there itself within the period of ½ hour.
- 5. A hand holding training will be given to the teachers on the following modules.
 - 1. e.Hazar
 - 2. CCE
 - 3. DCR &VCR
 - 4. APeKX
 - 5. TEPAC

Finance:

The amounts will be released to the course Directors in due course. Pay and release the funds for arrangements, TA/DA Charges to the participants and all other payments in respect of training programme should be done through **online only** and no cash & Cheque payments will not be allowed. The unit cost statement is enclosed.
