The Heads of institutions all recognized schools have to remit the Examination fee, fee for Under-aged candidates and fee for vocational candidates by clicking the button provided for the purpose in the application for NR generation hosted in the website [www.bscap.org](http://www.bscap.org) from 21-11-2019 onwards as per time schedule.

- (2) Due dates of remittance of Examination fee will not be extended further under any Circumstances.

**IMPORTANT NOTE:**

1. Fee for Regular candidates for all Subjects is Rs. 125/-
2. Fee more than 3 Subjects is Rs. 125/-
3. Fee for upto 3 subjects is Rs.110/-
4. Fee for vocational candidates is Rs 60/- in addition.
5. Fee for Under-aged candidates is Rs.300/-

6. Online Applications link will be available in [www.bseap.org](http://www.bseap.org) website. The applications of all the candidates shall be uploaded online without fail.
7. The candidates belonging to Scheduled castes/ Scheduled tribes and Backward classes whom are appearing for SSC MARCII- 2020 for the first time as regular candidates and whose parental income does not exceed Rs.24,000/- per annum in urban areas and Rs 20,000/- or land holding not exceeding 2.5 Acres wetland/5 acres dry land in rural areas are exempted from the payment of examinations fee. As such the Headmaster is requested to satisfy themselves about the Parental income by insisting upon a certificate issued by the Mandal Revenue Officer (M.R.O) as per rules.


