With reference to your letter dated:12.01.2026, the following are the replies for the issues raised:

Filling up PGT vacancies out of the total 1,752 posts working under the deployment system in 292 Girls High School Plus institutions established under Zilla Parishad and other managements	A proposal were submitted to the Government for filling up of vacant teaching posts in the High Schools Plus functioning in the Academic Year 2025-26 and Government orders are awaited
2.	210 previously established Co-Education High School Plus institutions should be revived, and new PGT posts should be filled through promotions in these schools	
3.	The posts of M.E.O. 1 and M.E.O. 2 should be filled only with ZP teachers.	The Government, vide G.O.Ms.No.154, School Education (Services-I) Department, dated 16.09.2022, created (i) 13 MEO-I posts in addition to the existing 666 sanctioned posts and (ii) 679 MEO-II posts for effective monitoring of academic and non-academic activities.

		<p>Further, the Government, vide Memo.No.1438516/Ser.I/A1/2021, dated 14.06.2023 have accorded permission to fill up the posts of MEO-II (i) with the existing MEOs (MEO-I) of Z.P Management (by transfer) and (ii) with the HM Grade-II in Z.P. Management Schools (by transfer based on seniority and willing), subject to the outcome of all the Writ Petition (AT)s/ Writ Petitions/ Contempt cases and SLP if any pending before the Hon'ble Courts.</p> <p>Accordingly, all the RJDSEs have filled up the Mandal Educational Officers-II posts.</p> <p>However, the filling up of MEO-I &amp; II posts is presently sub judice before the Hon'ble High Court of Andhra Pradesh in W.P.Nos.30879 of 2022, 10035 of 2024 &amp; 10164 of 2024.</p>
